## CITY OF SOLDOTNA RESOLUTION 2021-001

## A RESOLUTION UPDATING THE SOLDOTNA REGIONAL SPORTS COMPLEX COVID-19 PROTOCOLS

WHEREAS, in response to the November 12, 2020 Emergency Alert issued by Governor Mike Dunleavy the Soldotna Regional Sports Complex (SRSC) was closed on November 13, 2020 until further notice; and

WHEREAS, on December 18, 2020 the SRSC was Re-Opened with updated COVID-19 Facility Protocols; and

WHEREAS, the Soldotna Regional Sports Complex was operating with limitations and mitigation procedures prior to its closure; and

WHEREAS, the COVID-19 case counts in the Central Peninsula are currently declining;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SOLDOTNA, ALASKA:

- <u>Section 1</u>. <u>Masks:</u> All persons entering the building are required to wear masks at all times, except athletes when they are on the ice. Coaches and officials must wear masks at all times, even when on the ice.
- <u>Section 2</u>. <u>Games and Scrimmages</u>: For Youth Hockey, High School and Rusty Blades is allowed.
- <u>Section 3.</u> <u>Arrival / Departure Times</u>: All persons entering the building may arrive 15 minutes before ice time and must depart 15 minutes after ice time.
- <u>Section 4</u>. <u>Hockey On-Ice Capacity</u>: The allowed on-ice Capacity numbers includes players, coaches and officials and are established as follows:
  - a. 44 on the ice for U6 and U8
  - b. 32 on the ice for all other hockey events
  - c. 25 on the ice for freestyle skate
- <u>Section 5.</u> <u>Public Skate On-Ice Capacity</u>: The allowed on-ice capacity during public skate is limited to 40 persons per session.
- <u>Section 6</u>. <u>Spectators</u>: Only 80 spectators shall be allowed in the building during any ice event.
- <u>Section 7</u>. <u>Team Rooms</u>: Team rooms will be open.
- <u>Section 8</u>. <u>Hockey Organization Responsibilities</u>: All Hockey organizations shall identify a COVID-19 Point of Contact. The designated point of contact shall be responsible for the following: Informing players, parents, coaches and officials of the SRSC facility protocols; establish check-ins for all practices and games and perform a health screenings at all check-ins for practices and games; and shall maintain an attendance log for practices.

<u>Section 9</u>. This resolution shall become effective immediately upon its adoption.
